- Your USUCCU or other checking account active for a minimum of 90 days.
- Payroll deposited to your USUCCU or other active checking account regularly.
- Continuous employment for the last six (6) months.
- Home or work phone number where you can be reached in the evening up to 9 pm.
- Minimum of 18 years of age.

APPLICATION PROCESS

Step 1

Complete the loan application in black or blue pen. All questions must be answered completely. **We are unable to process an incomplete application.**

Step 2

Fax the loan application from any fax machine to (877) 507-6071 between 8 am and 5 pm, MST. Applications received after 5 pm will be processed on the next business day.

First time borrowers, please include the following:

- Most recent checking account statement
- Most recent pay stub
- Most recent utility bill
- Copy of valid ID

Step 3

Wait for a fax response. Upon approval the following documents will be faxed to you:

1. Instruction Cover Sheet
2. Privacy Disclosure Statement
3. Note Draft Disclosure Statement

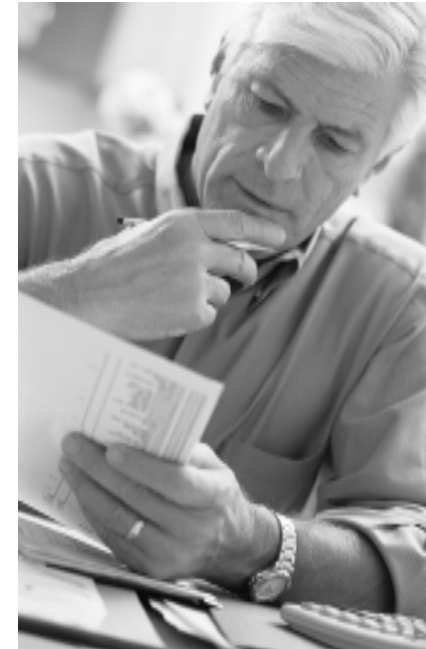
Fax back your signed Note Draft Disclosure Statement.

If we receive your signed Note Draft Disclosure Statement by 5 pm, **and you are a member**, you have the option of funds being deposited into your checking account on the next business day, or you may request a voucher to receive your funds immediately via the teller. **If you are a non-member**, funds will be deposited into your checking account the next business day. If we receive your signed Note Draft Disclosure Statement after 5 pm, the funds will be available the second business day.
